# California Cool<sup>®</sup> Zone-by-Zone

California applies its Building Energy Efficiency Standards (Title 24, Part 6) according to 16 climate zones across the state and a separate climate zone for Los Angeles. The map and table illustrate how all climate zones demand one of three different SRI (solar reflective index) minimums. Providing the best service for your customers means knowing their California Climate Zone.

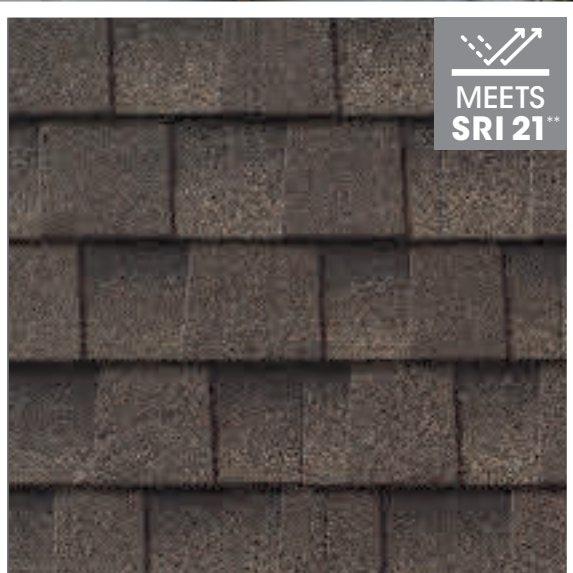


